hereby apply for admission to Residence for the above-mentioned period, and undertake:

1. To pay the required minimum fee within 14 days from the date of the notification of the reservation of accommodation in the Residence, failing to comply with this rule will result in the cancellation of my accommodation without any notice.
2. To give the College notice, in writing, no later than 31 October, of any intention not to take up the accommodation and accept that, on failure to take up the accommodation without such notice, the College may summarily cancel such accommodation in which event I shall forfeit the said deposit.\*
3. To allow the College, should the accommodation be taken up, to set off the said admission fee against the first residence fees becoming due.
4. In order to ensure accommodation on returning to the Residence, to pay the minimum fee within such period as stipulated in the notification of the reservation of accommodation in the Residence. The minimum fee will be offset against my residence fees on my re-commencing such accommodation and I accept that I will forfeit my minimum fee should I fail to take up the reserved accommodation.
5. Should I terminate my accommodation for any reason before the end of a semester, I will forfeit all fees already paid and remain liable for all unpaid fees, without prejudice to the right of the College to claim payment of any other amounts I may owe, whether as a result of my breach of contract or otherwise.
6. In the event of me booking accommodation for both semesters in any year, to give the College at least one term written notice of any intention not to return to the Residence for the second semester, I accept that on failure to give such notice, the College shall have the right to summarily cancel my accommodation, in which event I accept liability of payment of the second semester's residence fees, without prejudice to the right of the College to claim payment of any other amounts I may owe, whether as a result of my breach of contract or otherwise.
7. To accept the prescribed residence fees and other charges laid down by the College from time to time.
8. To pay the required minimum residence fees in full prior to taking up accommodation each semester. I accept that I will not be admitted unless the required minimum fees are paid in advance.
9. To accept the final decision of the College in the event of a dispute that may lead out of this agreement.
10. To accept and comply with the Code of Conduct for students and residences laid down by the College in respect of the Residence from time to time. Furthermore, I acknowledge that,
  - (i) a reduction of fees will not be granted should residence be taken up after commencement of a semester or in the event of termination of residence before the end of a semester, unless specifically agreed to by the College under special circumstances.
  - (ii) residence fees and other charges are subject to increase from time to time without prior notice.
  - (iii) the College shall have the right to summarily terminate my accommodation and evict me from the Residence should I breach any aforesaid undertakings, or should I cease to pursue my aforesaid course of study, without prejudice to the rights of the College in respect of any amounts I may owe it and the right of the College to claim further forfeiture of any balance of the minimum fee still held by it.
